OUR SERVICES TO YOU

The HIRE TRADE ALLIANCE agrees to provide services to you as a member of the scheme that you have chosen within this application. The HIRE TRADE ALLIANCE will provide and maintain a Code of Practice applicable to your membership. Revised Codes will be published via our website.

MEMBERSHIP TERM

Your membership term is one year. Your membership term will begin immediately upon acceptance of it by us.

RENEWAL AND TERMINATION

At the expiry of your membership term your membership will automatically renew for the same period as you have applied for within this application. Where you have applied to pay in instalments, this will apply to the renewed period of membership. The fees for membership shall be at the prevailing rate at the time of renewal. You also agree to abide by the HIRE TRADE ALLIANCE's Code of Conduct as it appears to be from time to time. You may cancel automatic renewal by providing 30 day's written notice to the HIRE TRADE ALLIANCE prior to the renewal date.
